Otherwise, the overall credit limit of up to four times your monthly income applies to your total outstanding unsecured amount for UOB credit card(s) and UOB unsecured facilities and any increase in credit limit from this application will be accorded to your UOB CashPlus account only. Credit limit is pegged to your prevailing earned income. Please note that should your income documents reflect a higher or lower earned income, we will adjust your current credit limit according to your prevailing earned income. The Bank reserves the right to request additional documents.
